### **Terms & Conditions:**

\_\_\_\_ First month's board must be paid prior to horse arriving at FFR.

\_\_\_\_ Each month's board is due on the first of the month; a bill will be provided which will include the board fee for the coming month plus any other fees incurred (farrier, deworming, medications, lessons, etc) from the previous month.

\_\_\_\_ Late payment after 3 days will incur a \$5 penalty per day.

\_\_\_\_ LIMITATION OF ACTIONS. Any action or claim brought by Owner against Stable for breach of this Contract or for loss due to negligence must be brought within one (1) year of the date such claim or loss occurs.

\_\_\_\_ Risk of Loss and Standard Care: During the time that the horse(s) is/are in custody of FFR, LLC, FFR shall not be liable for any sickness, disease, theft, death, or injury which may be suffered by the horse(s) or any other cause of action, whatsoever, arising out of or being connected with the boarding of said horse(s), except in the event of negligence on the part of FFR, LLC, its agents, and/or employees. This includes, but is not limited to, any personal injury or disability the horse owner, or owner's guest may receive on FFR, LLC premises.

\_\_\_\_ Owner may store certain tack and equipment on the premises of Stable at no additional charge to Owner. However, Stable shall not be responsible for the theft, loss, damage or disappearance of any tack or equipment or other property stored at Stable as same is stored at the Owner's risk. Stable shall not be liable for the theft, loss, damage, or disappearance of any tack or equipment taken to horse shows or clinics.

\_\_\_\_ An approved riding helmet must be worn when riding by all riders. Proper footwear must be worn when riding and no open toe shoes in the barn.

\_\_\_\_ Sweep up before and after you ride to keep barn aisle clean for other clients.

\_\_\_\_ Owners are asked to provide: UTD Coggins and vaccination records; necessary horse clothing & equipment.

\_\_\_\_ Horses are wormed on a regular schedule and FFR will bill clients for the dewormer.

\_\_\_ Additional services not listed as part of the board package shall be subject to additional fee charges as listed FFF pricing schedule.

\_\_\_ **INHERENT RISKS AND ASSUMPTION OF RISK.** The undersigned acknowledges there are inherent risks associated with equine activities such as described below and hereby expressly assumes all risks associated with participating in such activities. The inherent risks include, but are not limited to the propensity of equines to behave in ways such as, running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in an injury, harm or death to persons on or around them; the unpredictability of equine's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals; certain hazards such as surface and subsurface conditions; collisions with other animals; the limited availability of emergency medical care; and the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within such participant's ability.

\_\_\_ FFR has the right to raise board prices at their discretion with a 30 day notice.

\_\_\_ FFR requires 30 days notice by boarder to terminate this contract. All outstanding bills must be paid to FFR before the horse leaves the property.

\_\_\_ FFR reserves the right to cancel this contract at any time and boarder will be required to remove their horse within 30 days notice.

**ENTIRE AGREEMENT:** This contract represents the entire agreement between the parties. No other agreements, promises, or representations, verbal or implied, are included herein unless specifically stated in this written agreement. This contract is made and entered into in the State of Vermont, and shall be enforced and interpreted in accordance with the laws of said State.

**ENFORCEABILITY OF CONTRACT:** In the event one or more parts of this contract are found to be unenforceable or illegal, the other portions hereof shall be deemed in full force and effect.
